The Washington State University (WSU) Department of Clinical Sciences (VCS) seeks to fill a tenure-track, full-time, 12-month position in its Veterinary Teaching Hospital (VTH) in the Veterinary Clinical Pathology unit. The position is offered at the Assistant Professor rank, and is available July 1, 2012. The position will join a team whose primary mission will be clinical teaching, service and scholarship.

**RESPONSIBILITIES**: The successful applicant will have responsibility for participation in didactic/clinical teaching of professional veterinary students, interns, residents, and graduate students, provision of diagnostic service for the Veterinary Teaching Hospital, development of an independent or collaborative research program, and provision of service to the University and veterinary community. The successful applicant must be able to effectively communicate and work with a diverse group of people.

**QUALIFICATIONS:** The candidate must possess a DVM or related degree and be boardeligible or certified in ACVP or ECVCP. Preferred qualifications include board certification in ACVP or ECVCP, an advanced degree, a record of research or scholarly productivity, evidence of expertise in teaching and diagnostic service, and a demonstrated ability to work with others in a team atmosphere.
